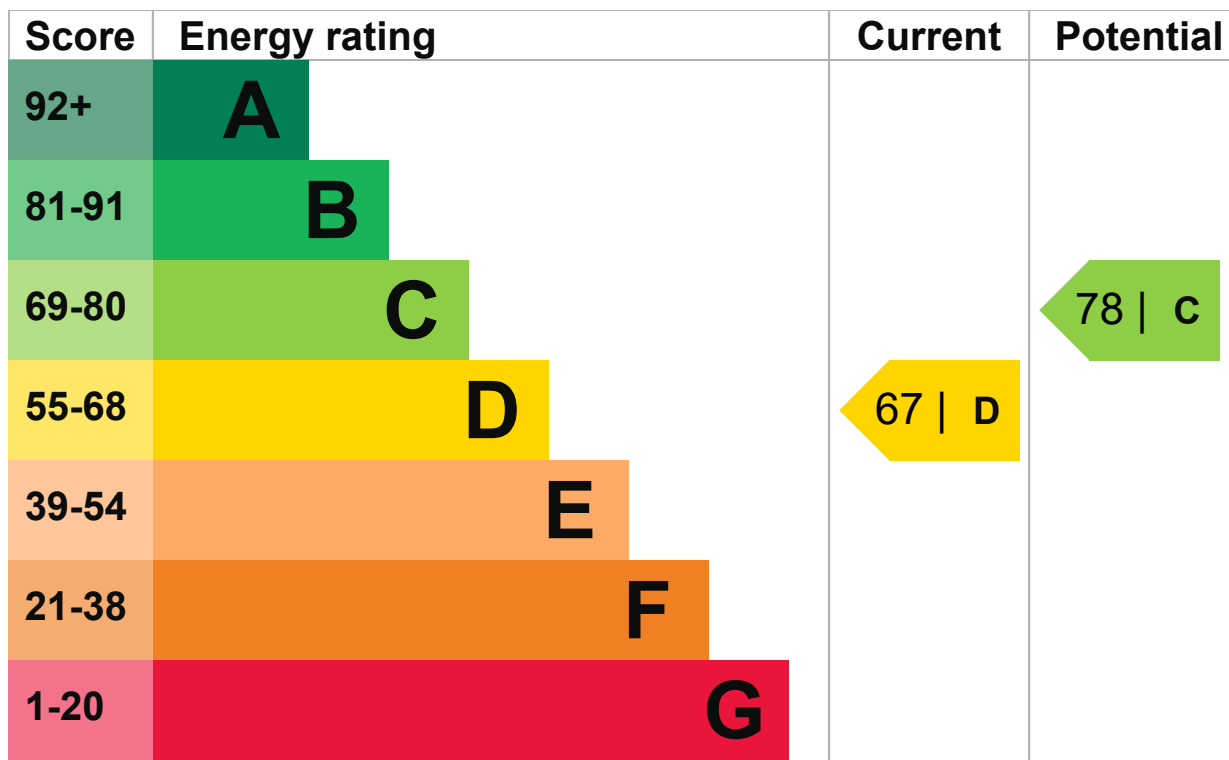

### Energy efficiency rating for this property

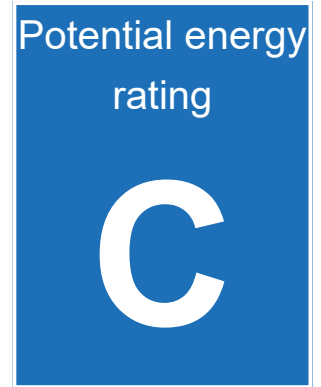
