

Rules on letting this property


Properties can be rented if they have an energy rating from A to E.

Primary energy use

Environmental impact of this property

One of the biggest contributors to climate change is carbon dioxide (CO2). The energy used for heating, lighting and power in our homes produces over a quarter of the UK's CO2 emissions.

An average household produces	6 tonnes of CO2
This property produces	2.9 tonnes of CO2
This property's potential production	2.2 tonnes of CO2

By making the <u>recommended changes</u>, you could reduce this property's CO2 emissions by 0.7 tonnes per year. This will help to protect the environment.

Type of assessment

RdSAP (Reduced data Standard Assessment Procedure) is a method used to assess and compare the energy and environmental performance of properties in the UK. It uses a site visit and survey of the property to calculate energy performance. This type of assessment can be carried out on properties built before 1 April 2008 in England and Wales, and 30 September 2008 in Northern Ireland. It can also be used for newer properties, as long as they have a previous SAP assessment, which uses detailed information about the

property's construction to calculate energy performance.
